
## CONCLUSION

The study is point out only the street operated informal sector enterprises which are largely help to make a live street as a space. It is also important component of the city both in terms of economy, socially and also in built environment.

Street is a sequence of spaces, which compromise the walkways, transitional spaces, nodes, junctions and squares. These elements will also help to attract the street operated informal sector. As because it helps and makes the spaces for their wants.

At present there are many difficulties associated with their presence of them in there. Lot of security, sanitary and social problems occur due to that. The norms and attitudes of the society also create problems to them. But still they can accommodate within the street spaces in a more appropriate manner to bring out a meaningful built environment or a city outlook.



As any space, a street space also is perceived by its users as mental schemata, composed mainly of a centre, enclosure and continuity. Therefore a street space has to be organised as it suggests well-perceived relationships between objects to construct the above for and better habitation of its users.

A placed that is appropriate for street operated informal sector is viewed in the light of the above at the end. It is found that there are ideal locations at each of these street spaces that can be provided for street operated informal sector. The ways of accommodating informal sector in the built environment of the streetscape is examined from few examples. There successfulness and the negative points and positives are also mentioned. The way illustrated and discussed here may not be the only way there can be many other positive responses.



It is clear that if the urban designers want to make a meaningful urban environment they have to provide spaces and accommodate the informal sector within the street. Better understanding of the behaviour and about the informal sector, proper consideration on all sectors of the urban built environment will bring out solutions towards the architecturally sound built environment.

This will be a threshold more elaborated research on this matter and much work is required with a careful listening to the informal sector and other relevant fields in order to bring the informal sector more effective productive way towards creating a pleasing built environment.
