ABSTRACT

In a way this will help to reduce the negative feelings of the individual humans like social phobia, anomie situations, stresses. Hence it represent a balanced healthy nation altogether. Therefore it helps them to retain a sensible appreciation of creations rather than torturing it by, graffiti or vandalism. Communities within a country can be categorized according to race, religion, occupation, education, and topographical situations.
